## • Based on the above stipend amounts, VA students should not have any debt that is not covered by the projected benefit amount.

Chapter 35 dependents and survivors will need to cover the difference between benefit amount and total cost.

Veteran students who are eligible are encouraged to apply for the Pell Grant program (Federal Title IV). Any credit balances on the Veterans' account will be disbursed to the student after completion of each semester/term. This timeline is necessary to ensure the VA stipends received by the student are fully earned.
